1. Meeting Called to Order

Mayor Pro Tempore John Dotson called the meeting to order at 12:06pm.

2. Adjust and Approve the Agenda

Commissioner Patterson made a motion to approve the agenda as presented, which was seconded by Commissioner Calloway and the vote was unanimous.

3. Review Hollingsworth Subdivision Application

Town Manager Josh Ward stated the request is for the approval of the preliminary and final plat for a subdivision of property located at 575 Satulah Road, PIN #7449470546. The current parcel is a total of 3.32 acres and is zoned R-1 Residential. The proposal will subdivide a 0.75 acre lot from the parent parcel, which will be purchased by the Town for placement of a new water tank.
